#### **Types of Cost:**

A one-time professional services fee will be charged for any implementation services required by Netsmart.

A recurring maintenance fee will be required for each product that is purchased by the client.

Clients may be required to purchase an additional server to provide the capabilities required for these measures. Additionally, an SSL certificate for external communications is required to enable the capabilities outlined. By nature, the SSL certificates are set to expire. If clients do not actively manage these certificates and provide updates to Netsmart when the new certificates are received, flow of information between the EHR and other solutions could be impaired.

In many instances, clients may have already accounted for this based on other solutions they have enabled outside of those required for meaningful use. In those scenarios, no additional servers or certificates are required.

#### **Limitations:**

Each connection point is configured by Netsmart as part of the MU Certified solution. Clients select the number and types of connections they require to outside organizations. All HIEs or point to point connections required for referrals and registries are configured and setup by Netsmart.
