#### All measures Tested

##### Types of cost:

An initial license of TIER is required as well as on-going yearly maintenance costs. There is also a one-time implementation fee for the capabilities required for criteria outlined in this document.

##### Types of Cost:

A recurring subscription is required. Additionally, clients may be required to purchase an additional server to provide the web service capabilities required for these pieces of functionality to be enabled. Additionally, an SSL certificate for external communications must be purchased to enable the capabilities outlined.

In many instances, clients may have already accounted for this based on other solutions they have enabled outside of those required for meaningful use. In those scenarios, no additional servers or certificates are required.

For clients who are hosted by Netsmart Technologies, no additional certificates or hardware is required. All of these are guided in their contract that they sign with Netsmart.

##### Limitations:

Each connection point is configured by Netsmart as part of the MU Certified solution. Clients select the number and types of connections they require to outside organizations. All HIEs / point to point connections for referrals / laboratories and registries for example are identified on the contract. As part of the implementation all of these are configured by Netsmart.
